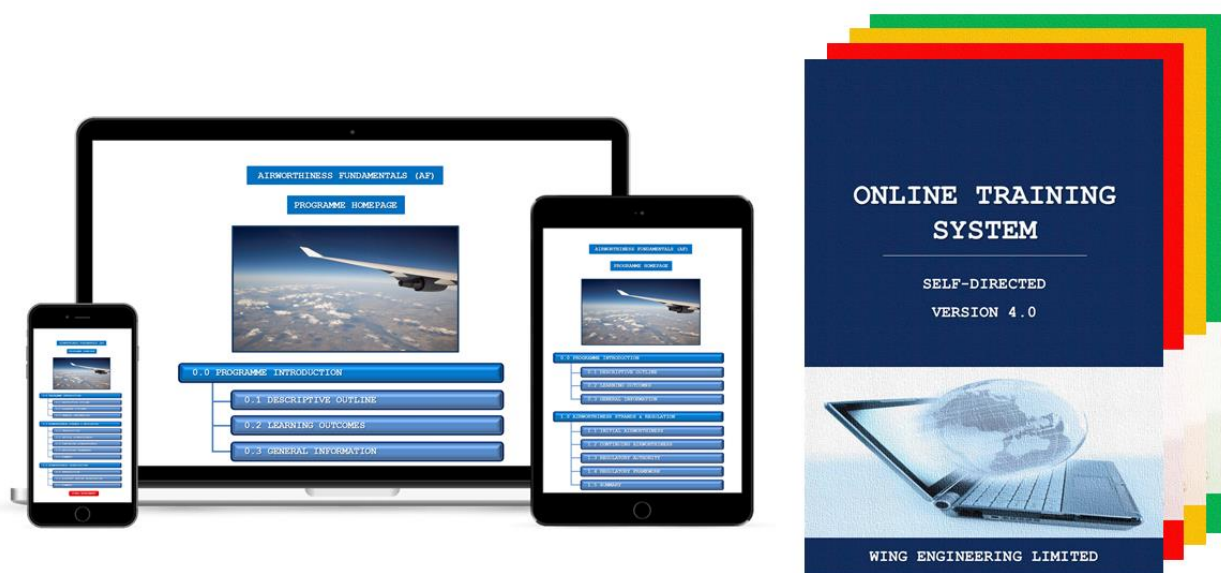

## **HOW ARE YOUR RATES SO INCREDIBLE?**

We are able to offer such great rates without compromising on quality due to the economies of scale of our self-directed online training system.

## **WHAT ARE THE CURRENT LICENCE RATES?**

The current annual licence rates are as follows:

- CAT A:** £3,995 per annum for corporate clients with 01 to 09 personnel
- CAT B:** £4,995 per annum for corporate clients with 10 to 49 personnel
- CAT C:** £5,995 per annum for corporate clients with 50 to 99 personnel

## **WE HAVE 80 PERSONNEL BUT REQUIRE THE LICENCE FOR 40, CAN WE GO FOR CAT B?**

Yes, you can; even if you have 80 airworthiness/engineering personnel, we do not expect you to go for licence CAT C **IF** you only intend to use the licence for 40 of them.

## **CAN WE ADD MORE PERSONNEL TO OUR LICENCE?**

No, you cannot do so; once you have reached the max limit of unique users on your licence, you cannot add more users. However, you may upgrade your licence anytime at the prevailing rate.

## **CAN WE SUBSTITUTE PERSONNEL ON OUR LICENCE?**

No, you cannot do so; the max limit on your licence represents the number of unique users you can have during the licence term. Substitutions can only be made during renewal.

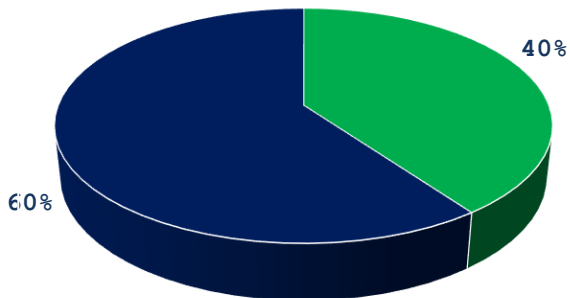

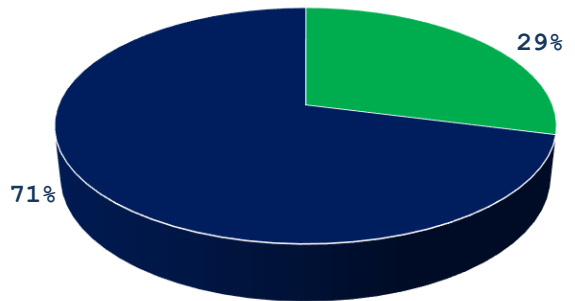

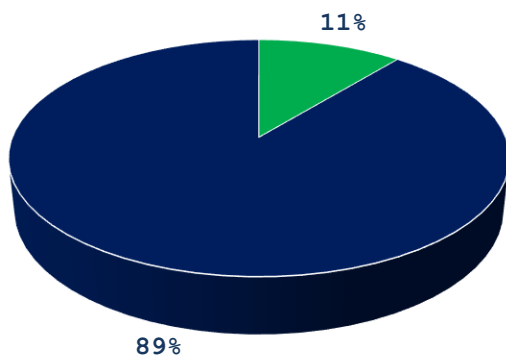
**2021 TRAINING FEEDBACK STATISTICS**



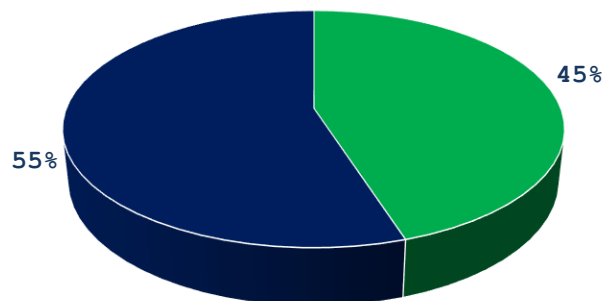
a.) Overall, how satisfied are you that the programme has delivered its Learning Outcomes (LOs)?
